# It Is A New Day!

It is a new day! Change is upon us. At our annual meeting, January 25<sup>th</sup>, we had the honor of Senator Charles Grassley as

a keynote speaker. He spoke of the future of healthcare. It is the first time since 1993 and Clinton's administration that healthcare reform has a chance for change and improvement. This gives each and every one of us an opportunity and a responsibility to be heard and make a difference in medicine, but we need your help! Polk County Medical Society Board of Directors, our lobbyists: Justin, John and Kathie Lyman cannot do it alone. If we do nothing – nothing will change. It is time now for us to stand together and let our voices be heard in Washington and at the State Capitol on what is right for medicine and right for our patients. We are stronger together!

Now is your chance to help the uninsured and underserved. There are 47 million uninsured people in the United States. With the worsening recession and layoffs, these numbers are expected to increase. For every 1% rise in unemployment, there are 1 million people that become uninsured. Patients are in a panic. They want "it all" before their insurance runs out (such as colonoscopies, mammograms, prescriptions filled, etc). Some patients feel as if they are free falling. It is quite frightening to them.

PCMS is a part of the Volunteer Physician Network The VPN serves the uninsured and the underserved. PCMS is almost 1,000 members strong. We challenge you to see just one uninsured patient a week. If you do this, just imagine the difference we can make. If each of us sees one uninsured patient a week that is 52,000 people that have access to quality care. In 5 years, the number is over one-quarter of a million patients seen! Imagine the difference you can make in these patients lives by helping them to retain their dignity, their pride and have access to quality medical care. Together we are stronger! Call Kathie Lyman today to sign up for the Volunteer Physician Network that allows you to integrate the uninsured and underserved patients into your practice in a seamless manner

As we look forward to the next year, there are many advocacy issues, which Polk County Medical Society will continue to try to address. These include Medicaid. With recent budget cuts, a possible 4% decrease in your payment, we are lobbying congress for the Federal Match Program to increase dollars for the State Assistance Program.

Medicare remains a constant challenge for providers to get paid fairly in Iowa. Payment reimbursement needs to reflect the increasing costs of the practice of medicine. Our ability to get paid fairly in Iowa will have a trickle down effect to our

ability to recruit students into medicine and our maneuverability to get partners into our practice and retain our current partners in the state of Iowa. We continue to advocate in Washington to fix Iowa's Medicare payments to physicians.

In 2009, PCMS will continue efforts to look at the regulation of the insurance companies and their current Pay For Performance Programs. PCMS is striving for the **doctor** to establish the standard of care and quality of care for management for our patients' medical needs, **not** the insurance company dictating to us the standard of care. In the mean time, we need to teach our doctors the rating and measures that are currently used by the insurance company, so the providers can continue to receive and maintain an above average grading.

This is an exciting and rewarding time to be in medicine. One of the biggest innovations currently at hand is electronic medical records. It is difficult for many of us to scrap a medical chart, an efficient system that is time tested, to now look at a system that is painful to learn. As we watch our teenagers simultaneously watch a big screen TV (split ½ football game the other

½ video game) with computer on their lap searching the Internet, iPod earplugs in, while text messaging someone on their phone - all while doing their homework and maintaining 4 point grade averages, the future of medicine is going to explode in technology as these bright students become our future doctors.

But, when it's all said and done, a patient still needs a doctor when they are laying flat on their back on a gurney in the emergency room suffering a heart attack and the attending doctor asks, "Who is your doctor"? Let's hope a patient never says, "Dr. Kiosk at Walgreens on 86th Street"!

Our patients still need a compassionate, caring provider to look into their eyes as they share their health concerns. Patients still need the caring hand of their doctor on their shoulder as they grieve the loss of a family member. And our patients still need us to hold their hand compassionately as we help lead them to better health. I encourage you to get involved with PCMS this year! Make a difference! Choose to do something!

## 66 Legislative Report ??

The 2009 session of the Iowa Legislature convened January 12<sup>th</sup> facing difficult economic challenges on the heels of natural disasters that impacted nearly every corner of the state. Clearly, the focus this session is on disaster relief and putting together a state budget that works. Democrats control the Governor's office and the Legislature (House has 56 Democrats to 44 Republicans and the Senate has 32 Democrats to 18 Republicans).

In his Condition of the State speech, Gov. Culver proposed appropriating \$43 million from the state's Economic Emergency Fund to provide financial support to communities and individuals impacted by the record flooding and tornadoes of 2008. The Legislature approved \$56 million for these purposes. The Governor is expected to approve this legislation.

Iowa faces a \$779 million budget gap in FY2010 according to the Legislative Services Agency. This means authorized or anticipated expenditures exceed projected revenues by \$779 million in the coming fiscal year. Additionally, Gov. Culver has ordered \$167.7 million in budget cuts for the current fiscal year, FY2009, to keep pace with falling revenues.

Of particular interest to the members of the Polk County Medical Society, the Department of Human Services announced it may reduce Medicaid payments to providers by 4% in order to meet the Governor's FY2009 cut. The reduced provider payments would be put into effect on March 1st unless the Congress approves additional Medicaid money for the states in the economic stimulus legislation under consideration

#### FEATURE ARTICLE

Gov. Culver's proposed FY2010 budget reduces General Fund net expenditures by \$88.5 million as compared to FY2009. The Governor's FY2010 budget applies the 6.5% cut to the Medicaid budget along with most state programs. Congress is considering additional money for Medicaid in FY2010. We will be working with legislators involved in appropriations for Medicaid to address the needs of health care providers.

Sen. Hatch unveiled SF48, a health care reform bill, in late January. It includes a provision that will indemnify providers that provide specialty care in their offices. This provision will enhance the medical services doctors offer through the Volunteer Physician Network. PCMS leadership discussed the idea with Sen. Hatch prior to the session. We worked with Sen. Hatch to include the provision in his health care reform bill

Other areas of interest to PCMS in SF48 are:

- Healthcare workforce shortage initiative – Creates a fund under the control of the College Student Aid Commission to provide grants to support medical residency training, a health care professional loan repayment program, a nurse educator forgivable loan program and nursing faculty fellowship programs. The fund may receive public and private funds.
- Prohibition and disclosure of gifts – Prohibits gifts from manufacturers and wholesalers of prescription drugs, biologics and medical devices to healthcare practitioners who participate in

- state health programs. Allowable gifts must be reported to the state by the manufacturers and wholesalers.
- Transparency The Department of Public Health will adopt rules to direct hospitals to submit data on inpatient, outpatient and ambulatory information to the Iowa Healthcare Collaborative

A regulatory issue impacting scope of practice is also under review by the Legislature. In December, the Iowa Department of Public Health and the Board of Physical Therapy/Occupational Therapy proposed a rule regarding physician ownership of physical therapy/ occupational therapy services. PCMS is opposing the rule, which would not permit doctors to hire physical/occupational therapists or have a financial interest in a physical therapist/occupational therapist group. The Legislature's Administrative Rules Review Committee certainly had concerns with the rule as proposed, and referred it to the Legislature for its review. To be clear, the rule will continue through the rulemaking process (the referral to the legislature didn't end the process). However, there will be further discussion with the Department of Public Health and the Board of Physical Therapy/ Occupational Therapy. PCMS will be involved in these discussions.

Two bills – SSB1001 and SSB1092 -- allowing physician assistants, nurse practitioners and others to form limited liability companies are being closely monitored by PCMS.

## Doctor's Day

n October 30, 1990, President George Bush signed a resolution designating March 30<sup>th</sup> as National Doctor's Day. In fact, the first Doctor's Day observance was held on March 30, 1933, by the Barrow County Auxiliary in West Georgia, the 91<sup>st</sup> anniversary of the day that Dr. Crawford W. Long first used ether anesthesia in surgery.

Since the days of the Hippocratic Oath, the physician has been held in high esteem as healer, trusted confidant and patient advocate. The relationship between physician and patient is invaluable during times of crisis. Technological breakthroughs have done much to advance the science of medicine; however, the patient-physician relationship remains the fundamental tenant of medicine. Patients depend on their doctors. And for good reason.

Doctors do more than keep patients healthy.
