PCMS LEGISLATIVE 9 9 BREAKFAST AT CAPITOL

The Polk County Medical Society met with over 50 lowa Legislators on Wednesday, January 27th at the Iowa Capitol. On behalf of physicians and their patients, members of the Polk County Medical Society advocated with the leadership and individual members of the legislature opposing SP 153 and the ability for physician assistants to form corporations

with physicians, and SSB 3085 support nullification of the Board of Nursing rule expanding ARNPs scope of practice to include supervising fluoroscopy. The doctors also support continued funding for the Volunteer Physician Network ensuring continued patient access to specialty care. PCMS members advocated for our 2010 legislative priorities

GOBESITY > >

In the medical community today there is a lot of discussion about health care costs and the cost of healthcare reform, I would like to suggestanalternate view. Perhaps as

physicians we should be addressing health rather than health care. If we could address preventive measures and therefore create healthier Americans, I suspect healthcare costs would plummet over time. Granted the immediate return on our investment would not be large, but over time billions of dollars could be saved.

Looking at just one area of healthcare: obesity, may demonstrate this point. According to the Centers for Disease Control and Prevention (CDC) obesity related conditions accounted for 10% of total annual medical expenses in 2008 or \$147 billion. Even a 20% reduction in the number of obese Americans would save billions of health care dollars yearly.

How large is the obesity epidemic in America? The National Health and Nutrition Examination Survey (N HANES) shows that 68% of US adults were overweight in 2007-2008. The obesity rate (BMI >30.0) rose from 13.4% to 33.8% over forty years. To paraphrase: most Americans are overweight and over 1/3 are obese. Some experts predict that at the present rate of weight gain, almost half of all adults in the United States would be considered obese by 2020. SHOCKING!

There is some good news in recent reports. Compared to the previous ten year period, the rate of increase in overweight and obese adults has slowed, but this is not good enough. We need to aggressively prevent obesity.

There are many presumed reasons for this obesity epidemic: increasing wealth and availability of food, food additives, and the proliferation of fast-food restaurants and jumbo sized portions of food just to name a few. We are also raising a society of inactive adults and children who consume many more calories than they burn.

What can we do to begin raising healthier and "lighter" Americans? Denmark has introduced legislation to tax trans-fats and sweets in addition to the tax on sodas they have already passed. There is no proof that this approach will work, but it is an interesting idea.

We have made huge strides in our battle against smoking with public health campaigns and education of our children. We need to increase our efforts to educate our children about nutrition, health, and exercise. The N HANES data suggest that already 17% of our school-age children are obese. There has been a move toward healthier school lunches and requiring physical education in school, but NOW IS THE TIME for a concentrated nationwide effort to prevent obesity and raise a healthier generation of Americans...

Scholarship Fund First Recipents

No I am certainly not retiring. Some of you may have wondered because after 20 years as your Executive Director, the Board established a Kathie J. Lyman scholarship fund for medical students recognizing my work with physicians and medical education. I am humbled by this honor.

Most of you know that my career has been working with doctors in Medical Staff and Medical Education. As the Administrator of Mercy Medical Education, I assisted in establishing the first medical student rotations with the medical students at Des Moines University, (formerly University of Osteopathic

Medicine and Health Sciences) in the early 70's. Over the years, along with the doctors and PCMS board, I have advocated for assistance with medical education costs. As the cost of medical education escalates this scholarship is timely and will provide support to medical students annually. One of the recipients will be from the University of Iowa Medical School and one from Des Moines University Osteopathic Medical School. The PCMS scholarship will provide the annual scholarship recipients

with \$1,000 each. The awards will be presented at the annual meeting which will recognize the medical student's scholarly achievements and financial needs.

It was very exciting for me to present the first Kathie J. Lyman Scholarship award of \$1,000 at the PCMS Annual Meeting on January 13th to Mackenzie (Mack) Worthington, a first year medical student from Des Moines University Osteopathic Medical School. Mack is the oldest of five children, four currently in college and the first in the family to pursue a medical degree.

Mack grew up on a farm in Central Iowa where he learned science in his hands with many types of livestock and caring for animals. His grandfather's lung cancer moved him to learn more about the challenges in health care in the US and also around the world. During his under grad at Simpson Mack volunteered for medical missions while helping on the farm. He witnessed the health conditions in three countries. Mack wrote in his essay: "I quickly learned the consequences of not having clean or boiling water, unsanitary medical practices in medical facilities, and can still picture a woman in labor with the roof falling in the room she had, seeing the sky in a delivery room. In Africa they had several nursing home patients in one bed and an AIDS crisis. It was my first attempt at patient education and experiencing non compliance with cultural patients. These global experiences along with my family health battles, volunteering at Iowa Methodist, led me to want to be a doctor. Mack thanked the Polk

County Medical Society for this scholarship which will allow him to continue his medical education and achieve his goal to sustain quality medical care for the communities in lowa".

The second scholarship was awarded to Gabriel Fierro-Fine, University of Iowa medical student. Gabriel is a second year medical student who grew up with little access to health care. That experience led him to want to become a doctor. He works in less desirable neighborhoods

to provide healthcare to the underserved. Seeing people denied basic healthcare due to income and language barriers has profoundly impacted his life. Gabriel this year was elected mayor by his peers at the Carver College of Medicine. He helped run a physician-medical student mentoring program for first and second year students to improve them both academically and professionally. He joined the Iowa National Guard Medical Corps to serve the lowa community and also to provide healthcare to the men and women who put their lives on the line for our state and country. Mr. Fierro-Fine was unable to attend the PCMS Annual Meeting. However, he sent a letter of sincere thanks to the Polk County Medical Society physicians for their support and assistance with medical education for him and other students.

My sincere thanks to all of the doctors who contributed to the Kathie J. Lyman Scholarship Fund. Your support sent a clear message that PCMS doctors are grateful to the young professionals who chose medical education, and ensures support of future medical students.

You can still contribute to this worthwhile scholarship as PCMS builds the fund. Your contribution can make a difference in the life of a medical student. Polk County Medical Society Legislative Report > >

January/February 2010

The 2010 session of the Iowa Legislature convened on January 11, 2010. The Governor and the Legislature are facing the worst national economic downturn since the Great Depression of the 1930's. The 2010 session will focus on budget issues. Democrats control the Governor's office and the Legislature (House has 56 Democrats to 44 Republicans and the Senate has 32 Democrats to 18 Republicans).

lowa faces a \$500 million - \$1 billion budget gap in FY2011 according to the Legislative Services Agency and the Department of Management. This means authorized or anticipated expenditures exceed projected revenues within this range in the coming fiscal year. Gov. Culver ordered a 10% across the board budget cut in October totaling approximately \$565 million in budget cuts for the current fiscal year, FY2010, to keep pace with falling revenues.

Of particular interest to the members of the Polk County Medical Society, the Department of Human Services has reduced Medicaid reimbursement rates to physicians by 5% as

part of their need to achieve a 10% cut across the department.

The Governor released his FY11 budget proposal on January 27th. Overall, it is a status quo budget, maintaining funding levels at the FY10 levels after the across the board cut. There are a few exceptions. The Governor fully funds Medicaid. Due to the phasing out of the federal stimulus money, the state's Medicaid share will increase by \$122 million. The Governor is proposing a \$180.8 million increase in Medicaid to cover the loss of federal stimulus dollars and expected increase in utilization.

Despite a challenging state budget, PCMS is pursuing full funding of its work to support the Volunteer Physician Network. Current funding is \$137,387. Actual cost is \$176,500. PCMS is providing in-kind services totaling \$39,113. PCMS is seeking full funding from the Legislature at \$176,500.

Sen. Jack Hatch and Rep. Mark Smith continue their work to reform lowa's health care system and increase affordable access to health care services for lowans. The centerpiece of this year's proposal will expand health care access for adult lowans to lowa Cares beyond Broadlawns Hospital in Polk County and University Hospital in lowa City. Subcommittee work on SF 2092 began February 1st.

SF 153, allows physician assistants, nurse practitioners and others to form limited liability companies. PCMS, the lowa Medical Society and others are opposed to the bill. As a result of work in the subcommittee and committee process, the nurse practitioners are no longer in the bill. PCMS will continue to monitor this legislation.

PCMS is supporting the Iowa Society of Anesthesiologists and the Iowa Medical Society's efforts to protect patients by defining the scope of practice for Chronic Interventional Pain Management and the use of fluoroscopy. The Board of Nursing approved an administrative rule allowing Advanced Registered Nurse Practitioners (ARNPs) to supervise the use of fluoroscopy in conducting Chronic Interventional Pain Management. No other state allows ARNPs to supervise fluoroscopy and very few permit it with a specified level of training and physician oversight. The rule makes Iowa an outlier and PCMS's concern is for patient safety.

Volunteer Physician Network 2009 Donated Care

Thanks to the PCMS specialists who provided over 1000 free Specialty Care referrals from the 59 Free Clinics in Iowa.

You, by your volunteerism, saved the State of lowa over *\$1,886,765.61 by providing free specialty care when needed to these uninsured through the VPN program.

Thanks to a grant from Prairie Meadows, interpretive services were provided to VPN patients when needed.

Thanks to our partnership with Des Moines hospitals, the VPN patients received inpatient hospitalization when needed.

The health care providers in Central lowa through their care and compassion allow patients to have access to quality care and an opportunity for a healthier life.
