POLK COUNTY MEDICAL SOCIETY 2023 Legislative Report

Below is a summary of noteworthy bills of interest for the Polk County Medical Society during the 2023 Legislative Session. Please that this is the first year of the 90th General Assembly. Legislation not enacted in 2023 is eligible during the 2024 session.

Bills Signed by Governor Reynolds

A HISTORICAL WIN FOR IOWA **PHYSICIANS!**

HF 161 A bill for an act relating to noneconomic damage WIN awards against health



providers, and including effective date and applicability provisions. Caps medical malpractice noneconomic damages at \$1 million for physicians \$2 million for hospitals. (Formerly HF 102.) (2/16 Signed by Gov.; 2/8 Passed Senate 29-20; 2/8 Passed House 54-46; PCMS Strongly **Supported**

HF 265 A bill for an act relating to midwife licensure, providing for fees, and making penalties applicable. (Formerly HSB 80.) The Senate modified the bill to allow certified nurse midwives to be involved in the rulemaking for midwives.

(6/1 Signed by Gov.; 5/3 Passed Senate 46-2; 5/3 Passed House 91-2; PCMS Opposed House bill, PCMS supported the Senate changes)

HF 424 A bill for an act providing for the collaborative practice of physician assistants by allowing for the practice of physician assistants without supervision by a physician. (Formerly HSB 115.) The Senate added back in a minimum of two years of physician supervision and required collaborative agreements.

(5/10 Signed by Gov.; 4/20 Passed Senate 48-1; 5/1 Passed House 88-6; PCMS Opposed the House bill, PCMS supported the Senate changes)

SF 561 A bill for an act relating to appropriations for veterans and health and human services and including other related provisions and appropriations, providing penalties, and including effective date and retroactive and other applicability date provisions. (Formerly SSB 1213.) SF 561 contains \$225,000 for the Volunteer Physician Network program.

(6/1 Signed by Gov. 5/3 Passed Senate 32-16; 5/2 Passed House 63-32; PCMS Monitored the overall bill, PCMS Support funding for VPN)

HF 635 A bill for an act relating to the requirements for a license to practice podiatry. (Formerly HSB 221.) Effective date: 07/01/2023 (5/3 Signed by Gov.; 4/24 Passed Senate 49; 3/15 Passed House 97-0; PCMS Supported)

SF 514 A bill for an act relating to the organization, structure, and functions government, of state providing for salaries of appointed state officers, providing for confirmation appointments, providing penalties, making appropriations, providing Code editor directives and transition provisions, and including applicability and effective date provisions. (Formerly SSB 1123.) SF 514 is the Governor's massive bill reorganizing state government. PCMS is monitoring the combining of DPH and DHS. DPH previously administered the VPN program, now it will be a division within HHS.

(4/4 Signed by Gov.;3/7 Passed Sen. 34-15; 3/15 Passed House 58-39; PCMS Monitoring)

<u>SF 75</u> A bill for an act relating to certain health facilities including ambulatory surgical centers and rural emergency hospitals, including licensing requirements and fees,

providing penalties and making penalties applicable, providing emergency rulemaking authority, and including applicability and effective date provisions.

(3/28 Signed by Gov.; 3/14 Passed Senate 47-0; 3/7 Passed House 97-1; PCMS Monitored)

HF 347 A bill for an act relating to the administration of injections by licensed optometrists. (Formerly HF 179.) Effective date: 07/01/2023.

(4/28 Signed by Gov.; 4/17 Passed Senate 48-2; 3/7 Passed House 90-8; PCMS Opposed)

HF 183 A bill for an act relating to the requirements for a prescribing psychologist or a psychologist with a conditional prescription certificate. (Formerly HF 23.)

(4/28 Signed by Gov.; 4/17 Passed Senate 50-0; 2/9 Passed House 95-0; PCMS Monitored)

Latest Action and Died

HF 626 A bill for an act relating to continuity of care and non-medical switching by health carriers,

health benefit plans and utilization review organizations, and including applicability provisions.

(Formerly SF96; PCMS SUPPORTED *Died in Second Funnel)

SF 326 A bill for an act relating to the ordering and administering of epinephrine auto-injectors to persons ages eighteen years and older by a pharmacist pursuant to statewide protocols. (Formerly SSB 1103.)

(Died on Unf. Bus. Cal.; PCMS Monitored)

HF 157 A bill for an act creating a nurse preceptor tax credit available against the individual income tax, and including applicability provisions. (Died in Ways & Means Cal.; PCMS Supported and collaborated for additional legislative language for Physician preceptor tax credit.)

HF 477 A bill for an act relating to the licensure of internationally trained physicians and including effective date provisions.

(Formerly SF 439; PCMS Monitored *Died in Second Funnel)

Polk County Medical Society met with lowa Senators Charles Grassley and Joni Ernst on May 9th, 2023, to discuss issues impacting medicine.

The Medicare Geographical payment disparity continues to top issues in Washington, that have a profound effect on physician reimbursement rates. PCMS is scheduling meetings in September with CMS to further the issue to gain a foothold on resolution.

The PCMS CEO advocated personally with your lowa Congressional Delegation on behalf of PCMS members. 4 key issues were discussed in depth:

 Medicare's Geographic Payment Disparity and SRG

- 2. Fixing Prior Authorization and Gold Carding
- 3. Health Care Workforce Expansion
- 4. CMS Audits
- 5. Price Gouging distribution of medical supplies

PCMS continued to advocate aggressively for the accuracy of the geographic adjustment factors under Medicare for lowa physician payments. With the SRG expiring soon, PCMS focused on early discussion with Senators prior to our fly in to D.C. with our physician delegation in September 2023.

Also discussed was physician concern for medical manufacturing/supply/ distribution and pricing effecting practices and the costs of medicine.

PLANNING FOR FUTURE HEALTHCARE EXPENSES

These days, you can insure just about anything. So, the question becomes "What is worth insuring?" The answer almost always boils down to how much you'll have to pay to insure the thing you don't want to lose.

Many of the clients I work with are concerned about how to pay for their future healthcare needs, particularly the costs associated with long-term care. Planning for these expenses can be tricky, because your future health is uncertain. One way to mitigate these expenses is to insure the risk. As you consider this, there are some important things to know.

On average, an American turning 65 in 2022, will incur \$120,900 in long-term care costs* in his or her lifetime. In my experience, that is much less than what most people believe it will cost. The average is far less scary than general opinion. The tricky part is that it's an average.

It's important to note that Medicare doesn't cover long-term care costs, so you can expect to pay those yourself. But roughly 6 out of 10* individuals turning 65 won't even spend anything on long-term care costs. Because of this, many people make the decision to do nothing. I think this is a possibility you should prepare for.

As a financial planner, I work with all my clients to come up with a game plan for this possibility. There are two ways of mitigating the risk of future healthcare costs:

- You can pay someone else to insure this risk.
- 2. You can act as your own insurer.

If you decide to work with an insurance company, they will create a pool of benefits that you can use if and when you need to use them. To access the benefits, you generally need to meet some qualifications first. These are called "ADLs" or Activities of Daily living. For example, if you can't get out of your bed and get dressed for the day, you would need some assistance. This could mean someone comes into the home or you go to

a facility. This is one example of qualifying to get access to the benefit pool. Here are the six "ADLs":

- 1. Bathing
- 4. Eating
- 2. Dressing for your day
- 5. Toileting
- 3. Transferring
- Continence

In the last 20-25 years, the costs for traditional long-term care insurance have been increasing, making them less affordable and less attractive to insure the risk.

The other option is to self-insure this risk. One of the best ways to do this is to build a Health Savings Account (HSA) now. Why is this the case? The HSA is triple tax-exempt, a unicorn in the tax code. If you contribute through payroll:

- You can avoid FICA taxes (Social Security & Medicare).
- The contribution is pre-taxed (you deduct this from your income).
- You can invest the money in your HSA, and
- · It grows tax deferred.

Later, if you use it for qualified medical expenses, it's a tax-free distribution.

These are two examples of how to insure the possibility of paying for your long-term healthcare needs. If you are wondering what your best option may be, reach out to Foster Group.



Polk County Healthcare Workforce Collaborative

2022, Polk County Supervisor Angela Connolly leaders from education requested and healthcare systems to look at ways we could work in collaboration to address workforce challenges that added to the crisis within our health care systems. The participants include Des Moines Area Community College, Grandview, Mercy College, Des Moines Broadlawns, UnityPoint University, and MercyOne. This group quickly identified that working together on collaborative solutions was essential to making a significant impact.

Over the past year, leaders from each of the institutions have met regularly, to advance the goals of meeting the needs around health care career exploration and student/employee support through education. This goal was designed to address the need for future providers and better address the health care shortage in all health care areas.

The group decided the most positive way we could make an impact would be to work collaboratively to support high school and college students through pathway navigators for career development and exploration. This is a long-term efficient solution to address the collective healthcare system needs and to bring into the pipeline individuals interested in health care careers.

The Collaborative seeks to raise awareness and excitement about a variety of health professions including surgical technology, medical assisting, respiratory therapy, nursing, other careers. This will allow the collaborative to educate more lowans regarding high demand occupations and employ these individuals in healthcare organizations in County and the State of Iowa. To serve the high school population a workbased learning navigator will engage students and educators through handsContinued from page 27

on exploration, information, and connection to professionals. Currently, each organization is receiving calls and emails from numerous teachers asking for 'shadowing opportunities' for students.

With this funding, the collaborative will be able to take a joint approach to supporting these requests and offer additional ways to learn about careers. To serve the college students pursuing their healthcare education, the collaborative will have a pathway navigator to help remove barriers to completion and connect students to their future employment.

The Collaborative has current funding to support these efforts for 3 years. We believe the success of this Collaborative will be demonstrated by increasing the number of individuals interested in a healthcare field, increasing the number of individuals

successfully completing healthcare education and training programs and increasing employment in healthcare fields for the State of Iowa. This model creates efficiencies for all parties, and we believe could be replicated throughout Iowa. We have hired the two positions and are within the first 90 days of implementation. Throughout the past year, Collaborative has proven that we are stronger working together and have built solid trusting relationships within the Healthcare community. We share a vested interest in the success of our community and continue to be thinking of solutions to create a solid health care workforce. We look forward to sharing the outcomes as data becomes available and results of the program can be measured.
